Strong performance in first 9M; Successful capital increase; BUY

What's it all about?

123fahrschule (123fs) was able to continue its positive development in the third quarter of 2023. The company achieved sales of EUR 5.2m, which in turn led to a balanced EBITDA. Reported key performance figures confirm our view, and we believe, the company is well on track to achieve its full year target of EUR 20m (eAR EUR 20.6m) and a balanced EBITDA (eAR). Following the successful capital increase, fresh funds of EUR 1.7m provide a comfortable financial cushion to reach the final introduction of online theory lessons into German law, which is expected at the end of H2 '24. Meanwhile, management can focus on operational growth. Therefore, we confirm our DCF based target price of EUR 7.20 and our BUY rating.

Strong performance in 9M; Successful capital increase; BUY

123fahrschule (123fs) reported on the business development of the first 9 months of 2023. At the end of the last financial year, management initiated and successfully implemented a series of optimization measures. This successful implementation is now reflected in the company's KPI's. The background to the optimization measures was the legal postponement of the introduction of online theory lessons.

Call back: Online theory classes expected from 2025. In Germany, online theory lessons were considered an exception during the pandemic. But, according to the Federal Ministry of Digital Affairs and Transport's, e-learning will be permanently recognized by law in Germany from 01.01.2025. At the moment, driving schools are only allowed to train their students in face-to-face classes. Back in 2016, 123fs set out to revolutionize the German driving school market with digital innovations. This is now expected to take place from 2025 onwards.

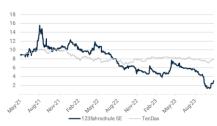
Q3/9M performance. 123fs was able to continue its positive development in the third quarter. The company achieved sales of EUR 5.2m, which in turn led to a balanced EBITDA (own calculation eAR; Q3 23 figures not provided). Looking at the first 9M, sales rose by a whopping 31% to EUR 15.6m. Consequently, a positive EBITDA of EUR 0.2m was achieved in 9M, which corresponds to a significant improvement compared to the previous year, when a loss of almost EUR 2.0m was generated. The overall positive development was carried by all three segments.

Fresh funds. In addition, the company issued c. 1.5m new shares, which increased the number of outstanding shares by c. 45% to 4.83m. The new shares came at a deeply discounted price of EUR 1.10/share, providing gross proceeds of EUR 1.7m. According to 123fs, there were subscriptions for a total of 6.6m shares, reflecting strong demand. In total, the measure was therefore overstated by a factor of 4.36x, which however, can be partly explained by the attractive discount.

Conclusion. Reported KPI's confirm our positive view, with the company being well on track to achieving its revenue target of EUR 20m (eAR EUR 20.6m) and a balanced EBITDA. With fresh funds of EUR 1.7m, we see 123fs with a comfortable financial cushion, to reach the final introduction of online theory lessons into national law. Meanwhile, management can focus on operational growth. We confirm our DCF-based target price of EUR 7.20 and our BUY-rating.

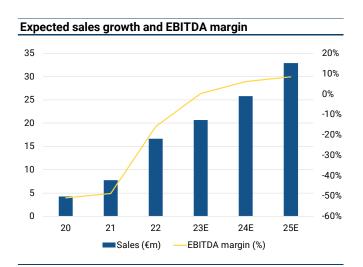

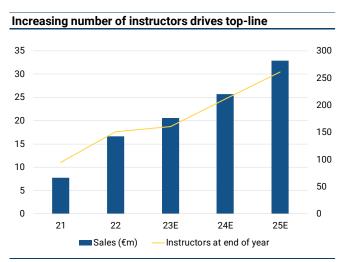

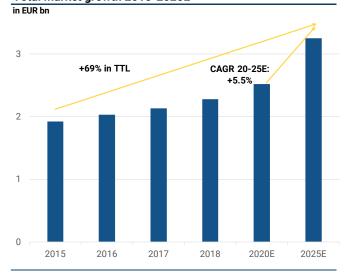


Investment case in six charts





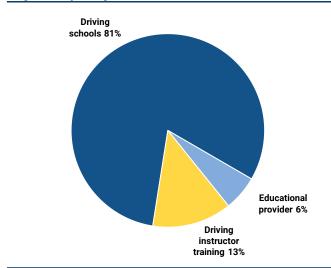
Total market growth 2015-2025E



Completely digital interaction via own ecosystem

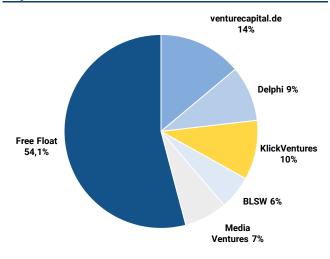


Segment reporting introduced with FY 2022

Company background

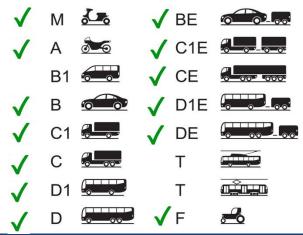
Products & services

123fahreschule SE is the disruptive force in the German driving school market. The company's goal is the modernization as well as the digitization of products, services, and processes. 123fahreschule aims to provide high-quality training for private and business customers nationwide. 123fahreschule operates digitally via its proprietary software and e-learning solutions, while many competitors still rely on premise theory lessons in a classroom. However, it is due to the regulatory framework that despite the digital approach physical sites (classrooms) must be operated regionally – at least one site per operating area (e.g., Berlin, Hamburg etc). Therefore, the company runs almost 50 schools at different locations in urban areas across Germany. The company currently employs 160 people, of which 97 are driving instructors (end of December 2021).

Covering the complete value chain

The 123fahrschule application (app) sets new standards by combining all necessary functions: students attend online classes, schedule driving lessons, learn for their theoretical exam, pay bills, and organize all the documents needed for a driving license. This app is a major USP in comparison to other driving schools in Germany. Furthermore, 123fahrschule owns a growing number of physical locations (e.g., Rhine and Ruhr Area, Hamburg, Berlin, Munich, Dresden, Leipzig). In total, a network of almost 50 driving schools was built up already (December 2021). 123fahrschule covers the full customer journey from the acquisition process to customer conversion, followed by the start of theory and practical lessons, as well as the passing of all exams needed, until the driving license is obtained. With the most recent acquisition of a driving school in Leipzig and in the Niederrhine region, 123fahrschule augments its portfolio by the B2B sector (e.g., truck and bus driver) activities. The product portfolio covers nearly all driving licenses in Germany.

Management

Boris Polenske studied business administration in Bochum, Germany. At the age of 16 he founded his first company "Klicksoft" for software development for the publishing and office industry. A few years later he founded the company "KlickTel", which he also successfully took public. Polenske then achieved a successful exit with the company, which was acquired by Telegate AG (now 11880 Internet Services AG). Polenske has always focused on digitalization. In 2016 he founded 123fahrschule Holding GmbH and is CEO. With this broad base of knowledge and experience, we believe that the company is well on track to transform the driving school market in Germany.

The management is incentivized via a stock option plan covering 181,448 shares, thus aligning management and shareholder objectives. This stock option programme is linked to the following targets, of which one goal must be achieved successfully:

- Market capitalization above EUR 100m
- Annual sales above EUR 100m
- EBIT above EUR 10m.

Financing milestones

After the founding in 2016, several venture capital firms invested in 123fahrschule, both prior to the reverse IPO and in following capital increases. Additional capital requirements could probably be covered by existing shareholders. However, with raised funds, the company is perceived to be financed for the time being.

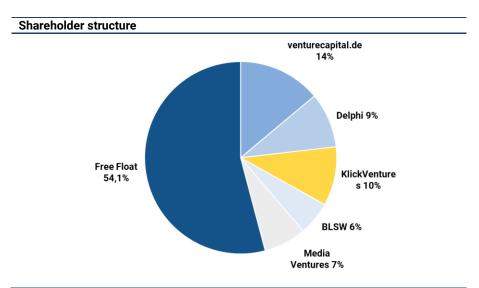






Shareholders structures

SWOT analysis

Strengths

- Scalable B2C business model

Valuation

DCF Model

The DCF model results in a fair value of EUR 7.20 per share:

Top-line growth: We expect 123fahrschule SE to grow revenues at a CAGR of 15.3% between 2023E and 2030E. The long-term growth rate is set at 1.5%.

ROCE. Returns on capital are developing from -16.4% in 2023E to 13.5% in 2030E.

WACC. Starting point is a historical equity beta of 1.65. Unleverering and correcting for mean reversion yields an asset beta of 1.33. Combined with a risk-free rate of 2.0% and an equity risk premium of 6.0% this yields cost of equity of 24.0%. With pre-tax cost of borrowing at 5.0%, a tax rate of 30.0% and target debt/equity of 2.5 this results in a long-term WACC of 9.4%.

FCF Yield Model

Due to the fact that companies rarely bear sufficient resemblance to peers in terms of geographical exposure, size or competitive strength and in order to adjust for the pitfalls of weak long-term visibility, an Adjusted Free Cash Flow analysis (Adjusted FCF) has been conducted.

The adjusted Free Cash Flow Yield results in a fair value between EUR -1.82 per share based on 2023E and EUR 9.87 per share on 2027E estimates.

The main driver of this model is the level of return available to a controlling investor, influenced by the cost of that investors' capital (opportunity costs) and the purchase price – in this case the enterprise value of the company. Here, the adjusted FCF yield is used as a proxy for the required return and is defined as EBITDA less minority interest, taxes and investments required to maintain existing assets (maintenance capex).

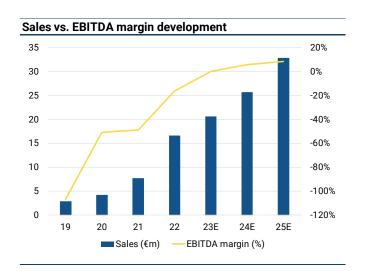

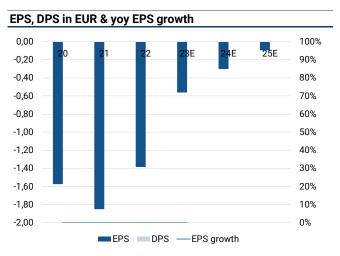
Simply put, the model assumes that investors require companies to generate a minimum return on the investor's purchase price. The required after-tax return equals the model's hurdle rate of 7.0%. Anything less suggests the stock is expensive; anything more suggests the stock is cheap. **ESG adjustments might be applicable.** A high score indicates high awareness for environmental, social or governance issues and thus might lower the overall risk an investment in the company might carry. A low score on the contrary might increase the risk of an investment and might therefore trigger a higher required hurdle rate.

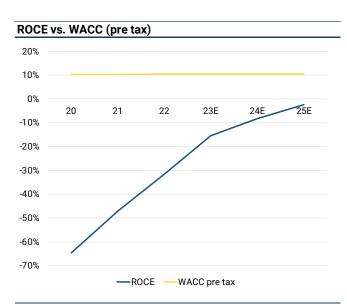


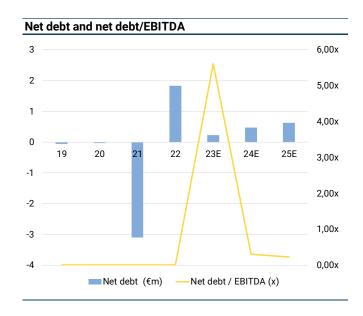


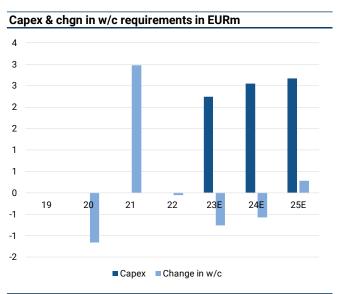
